SEALED BIDS for the furnishing of the necessary materials and construction of the

**Wood County Board of DD, Bowling Green, OH
Parking Lot Improvements**

will be received by the Wood County Board of Developmental Disabilities, 1921 E Gypsy Lane Road, Bowling Green, OH 43402, **until 10:00 a.m., Thursday, April 7, 2022**, and at that time and place will be publicly opened and read aloud.

The project consists of the installation of approximately 57,000 sq. ft. of asphalt mill and resurfacing, along with 71,000 sq. ft. of asphalt sealing, and necessary appurtenances. The estimated cost of construction is \$131,000.00.

The contract documents, including plans and specifications, are on file at the office of the Owner and the Engineer – Poggemeyer Design Group. The contract documents, including plans and specifications, are on file at the office of the Wood County Board of DD and the Engineer for the project: Poggemeyer Design Group, Inc., 101 Clinton Street, Suite 1300, Defiance, Ohio 43512.

All bids must be signed and submitted on the blanks which are bound in this booklet. Bids must state the unit prices in the blanks provided and be enclosed in a sealed envelope marked - - - **Bid for Wood County Board of DD Parking Lot Improvements - - - and addressed to** the Wood County Board of Developmental Disabilities, Attn: Mr. Scott McKeown - Health and Safety Coordinator, 1921 E Gypsy Lane Road, Bowling Green, OH 43402.

The bid guaranty may be of two forms:

1. A Bid Guaranty and Contract Bond using the form in the Contract Documents. (The amount of the bid does NOT have to appear on this form.)
2. A certified check, cashier's check, or letter of credit in favor of the Wood County Board of DD, in the amount of 10% of the bid. If the contract is awarded, a Contract Bond will be required, which is 100% payment and performance bond.

The successful bidder will be required to pay not less than the minimum wage rates established by the Department of Industrial Relations of the State of Ohio.

Bids received after the scheduled bid opening date and time, or not accompanied by a satisfactory bid bond or check, will neither be read nor considered.

The **Wood County Board of DD** reserves the right to reject any and all bids and to waive any irregularity in any bid and to determine the lowest and best bidder.

No bidder may withdraw his bid for a period of **60** days after the scheduled closing time for the receipt of bids. The owner intends and requires that this project be completed no later than October 15, 2022.
